

What is an abbreviated ACLS Renewal?

This half day course is designed for experienced ACLS providers who perform these skills on a frequent basis. Although the course includes skills testing stations, it is assumed that participants will arrive prepared to test with little practice and/or review. This Abbreviated version is nationally recognized by the American Heart Association and will provide the same AHA certificate (wallet card) to successful participants.

Abbreviated ACLS students will:

- Successfully demonstrate management of patients suffering from respiratory arrest.
- Successfully demonstrate management of witnessed cardiac arrest to include 1-rescuer CPR and use of an AED.
- Successfully demonstrate management of a patient in brady or tachy arrhythmias, VF/VT arrest and asystole or PEA.
- Pass the closed-book written test with a minimum score of 84%.
